**Course Objective**

To provide graduate students with practical experience in higher education teaching in Physiotherapy, developing pedagogical skills through active participation in the planning, delivery, and evaluation of the teaching–learning process in undergraduate courses, under faculty supervision.

**Course Content**

- Teaching Planning: participation in the development of lesson plans and schedules, definition of learning objectives, and selection of content and teaching materials
- Teaching Practice Execution: observation and participation in undergraduate theoretical and practical classes, preparation and delivery of supervised teaching activities
- Assessment: development and application of learning assessment instruments
- Self-assessment and Professional Development: preparation of reflective reports on experiences and challenges in teaching practice, including reflection on teaching performance and its impact on student learning

**Methodology**

Graduate students will actively participate in undergraduate teaching activities under the supervision of a responsible faculty member. The course includes class observation, planning and execution of teaching activities, and meetings for reflection on the teaching experience.

## **Assessment**

Assessment will be carried out through reflective reports, records of lesson planning and execution, feedback from the supervising professor, and self-assessment of teaching performance.
