**ADMINISTRATIVE ACT PPGFT Nº 5**

This document defines the Area of Concentration of the Postgraduate Program in Physical Therapy at UFSCar

The **Postgraduate Committee of the Postgraduate Program in Physical Therapy (CPG-PPGFT)**, affiliated with the Biological and Health Sciences Center (CCBS) at the Federal University of São Carlos (UFSCar), meeting on 08/02/2024 for its 285th Ordinary Meeting, in the exercise of the legal and statutory powers granted by the UFSCar Statute and General Regulations,

**CONSIDERING:**

- General Regulations of the Postgraduate Programs at UFSCar, dated April 1, 2021.
- Current Internal Regulations of the Graduate Program in Physical Therapy at UFSCar.

**RESOLVES:**

**CHAPTER I**

**AREAS OF CONCENTRATION**

Art. 1 The Postgraduate Program in Physical Therapy (PPGFT) at the Federal University of São Carlos (UFSCar) aims to offer academic Master's and Doctoral (*Stricto Sensu*) degrees, within the area of Physical Education, Physical Therapy, Speech Therapy, and Occupational Therapy — the area of knowledge in which the program is accredited by the Coordination for the Improvement of Higher Education Personnel (CAPES).

Art. 2 The PPGFT encompasses the Area of Concentration entitled "Physical Therapy and Functional Performance," supported by a highly qualified faculty with experience in advising, teaching, research, outreach, and project management.

Art. 3 The creation of new Areas of Concentration within the PPGFT may be proposed by interested

faculty members, the Evaluation Committee, or the Program Coordination by submitting a proposal to the PPGFT Postgraduate Program Committee (CPG-PPGFT). If the proposal for a new Area of Concentration is approved by the CPG-PPGFT, the Coordination will forward the request to the Postgraduate Council at UFSCar (CoPG-UFSCar) for approval.

## CHAPTER II

### GENERAL AND TRANSITIONAL PROVISIONS

Art. 4 Omitted cases shall be evaluated by the CPG-PPGFT.

Art. 5 This Administrative Act shall enter into force on the date of its publication in the SEI-UFSCar Electronic Service Bulletin, with any provisions to the contrary hereby revoked.
